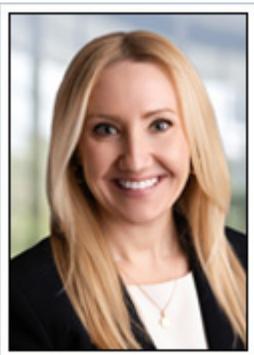
## **Alison B. Foley**
