## Two Ways to Invest

- Multi-Strategy Investing in a variety of strategies to create a globally diversified portfolio that is tailored to an investor's liquidity, income, and long-term growth needs.

## **Screening & Analysis**

The Manager Research Team uses a proprietary screening process to determine those third party strategies we believe are best-in-class, demonstrating consistent outperformance of peers and benchmarks over the long-term while taking less risk.

- Quantitative Analysis Assessing performance including absolute returns, risk, and risk-adjusted returns over rolling periods relative to peers and benchmarks
- Style Analysis Conducting holdings-based and performance-based analysis of a manager's style
- Qualitative Analysis Evaluating a manager's process, including philosophy, strategy, experience, research, discipline, and key decision makers
- Interviews & Evaluation Interviewing managers and evaluating existing literature, including the prospectus, annual report and other available documents


# **Monitoring**

Third-party strategies offered by Davenport are evaluated quarterly with a series of applied "watch list" screens using quantitative and qualitative analysis. This monitoring ensures that the strategies consistently meet our strict criteria for inclusion. If a strategy consistently or egregiously violates any of our criteria, we may revise our recommendations regarding the strategy. This criteria includes:

- Underperformance on an absolute or risk-adjusted basis
- Changes in investment philosophy, strategy or objective
- Style drift
- Changes in key personnel
- Regulatory or legal proceedings
